Please check the mare's status below and attach a negative culture report if required.

- Domestic Maiden Mare** – A negative uterine culture is required and must be taken within 30 days of the first cover but not later than 48 hours prior to the first cover. **ALL MAIDEN MARES MUST BE JUMPED (i.e., stand safely when mounted by a teaser stallion) BEFORE COMING TO THE BREEDING SHED.**
  - Domestic Barren or Not Bred Mare** – A negative uterine culture is required and must be taken within 30 days of the first cover but not later than 48 hours prior to the first cover.
  - Domestic Foaling Mare** (Date Foaled: \_\_\_/\_\_\_/2011) – No culture is required for the first cover.
  - Imported Maiden Mare** – A negative uterine culture is required and must be taken within 30 days of the first cover but not later than 48 hours prior to the first cover. Mare must comply with 2011 USDA & Kentucky Department of Agriculture regulations. **ALL MAIDEN MARES MUST BE JUMPED (i.e., stand safely when mounted by a teaser stallion) BEFORE COMING TO THE BREEDING SHED. A COPY OF THE QUARANTINE RELEASE MUST ACCOMPANY THE MARE ON HER FIRST TRIP TO THE BREEDING SHED.**
  - Imported Foaling or Barren Mare** – Contact the KY State Veterinarian regarding testing procedures and acquisition of a quarantine release for the 2011 breeding season. **A COPY OF THE QUARANTINE RELEASE MUST ACCOMPANY THE MARE ON HER FIRST TRIP TO THE BREEDING SHED.** A negative uterine culture is required and must be taken within 30 days of the first cover but not later than 48 hours prior to the first cover.
  - Returning Mare (2<sup>nd</sup> heat cycle)** – No culture required.
  - Returning Mare (3<sup>rd</sup> and all subsequent heat cycles)** – A negative uterine culture is required and must be taken within 30 days of the third cover but not later than 48 hours prior to the third cover.
  - Doubling Mare** – No culture required.

- Is a maiden mare that has not raced since December 1, 2010; or
  - Is a maiden mare raced after December 1, 2010, but that has resided on \_\_\_\_\_ breeding farm for at least **21 days** without signs of disease; **OR**
  - Is a maiden mare raced after December 1, 2010, but that was tested negative in 2010 on blood buffy coat PCR testing for EHV1 (*attach report please*).
