MARE MUST BE ACCOMPANIED BY THIS FORM EVERY TRIP and HAVE PROPER ID (HALTER/NECK STRAP) TO BE BRED.

Please check the mare's status below and attach a negative uterine culture report if required.

- Domestic Maiden Mare** – A negative uterine culture is required and must be taken within 30 days of the first cover, but not later than 48 hrs. prior to first cover. **ALL MAIDEN MARES MUST BE JUMPED (i.e., stand safely when mounted by a teaser stallion) BEFORE COMING TO THE BREEDING SHED – HIND SHOES SHOULD BE REMOVED.**
- Domestic Barren or Not Bred Mare** – A negative uterine culture is required and must be taken within 30 days of the first cover, but not later than 48 hrs. prior to first cover.
- Domestic Foaling Mare** (Date Foaled: ___/___/2020) – No uterine culture is required for the first cover. However if mare produced a foal that did not stand and nurse, a negative culture is required.
- Imported Maiden Mare** – A negative uterine culture is required and must be taken within 30 days of the first cover, but not later than 48 hrs. prior to first cover. Mare must comply with 2017 USDA & KY Dept. of Agriculture regulations. **A COPY OF THE QUARANTINE RELEASE MUST ACCOMPANY THE MARE ON HER FIRST TO THE BREEDING SHED. ALL MAIDEN MARES MUST BE JUMPED (i.e. stand safely when mounted by a teaser stallion) BEFORE COMING TO THE BREEDING SHED. HIND SHOES SHOULD BE REMOVED.**
- Imported Foaling or Barren Mare** – A negative uterine culture is required and must be taken within 30 days of the first cover, but not later than 48 hours prior to first cover. Mare must comply with 2017 USDA & KY Dept. of Agriculture regulations. **A COPY OF THE QUARANTINE RELEASE MUST ACCOMPANY THE MARE ON HER FIRST TRIP TO THE BREEDING SHED.**
- Returning Mare (2nd heat cycle)** - No uterine culture required.
- Returning Mare (3rd and all subsequent cycles)** - A negative uterine culture is required and must be taken within 30 days of the first cover, but not later than 48 hrs. prior to 3rd or subsequent covers.
- Doubling Mare** - No uterine culture required.

All mares visiting the breeding shed must be vaccinated for Equine Herpes Virus Type 1 (i.e. Rhinomune, Pneumabort K, Prodigy), in the last 7-90 days.
